1. Undertake design for new 11 KV switching substation including new building to house equipment, 11 KV switchgear board consisting of 16 panels, LV compartment, Local distribution transformer, Battery tripping unit etc. Design to be approved by the Municipal representative
2. Provide Tender documentation for the project
3. Undertake technical evaluation of bids with recommendations to Municipality
4. Attend all factory test and approved them
5. Oversee construction on site (Clerks of works) 1 Month
6. Attend commissioning of the all works
7. Handover project to Municipality

Details of ECSA Registered Professional Engineer who will be responsible for the project with qualification and all references to be submitted in the proposal. Please also note that Clerks of Work will be required to monitor construction on daily basis (Provision to be based on 30 working days)

A compulsory briefing session to be held at Inkosi Langalibalele Municipality offices, Civic building, Victoria Street, Estcourt on 29 June 2017 at 10:00 AM.

This tender will be evaluated on the 80/20 preferential procurement policy framework (PPPFA),), notwithstanding that the evaluation will also examine the experience of the tenderer which must be submitted with proof of experience in the form of the "Practical Completion Certificates" or "Final Completion Certificates" of at least 3 previous projects of similar size and nature.

The "Pre-qualification" evaluation criteria will be based on the following functionalities:

- Relevant Experience: 40 Points
- Methodology/ Approach 30 Points
- Qualification of Personnel 30 Points

Tenderers need to score a minimum of 70 % in terms of the "Pre-qualification" before the tender is considered for further evaluation.

Proposals and supporting documents must be placed in a sealed envelope and clearly marked “**Electrical Consulting Engineer to undertake design and oversee construction of new switching 11 kv Substation in Inkosi Langalibalele Municipality**”, which must be deposited in the Tender box at ground floor, Inkosi Langalibalele Municipality, Victoria Street, Estcourt, 3310 by not later than **24 July 2017 at 12h00**, where they will be opened and registered in public.

The Inkosi Langalibalele Municipality subscribes to the Preferential Procurement Regulations, pertaining to the preferential procurement policy framework act (PPPFA) principles whereby a tenderer's submission will be evaluated according to the sum of the award of points in respect of the proposal value and the B-BBEE status of the proposer. A valid ORIGINAL Tax Clearance Certificate MUST be submitted with the proposal document.

Tenderer's attention is specially drawn to the provisions of the bid rules which are included in the bid document and as follows:

- Inkosi Langalibalele Municipality Supply Chain Management policy will apply;
- Tenders which are late will not be accepted;
- Tenders will be valid for a period of 90 days.
- An original valid tax clearance certificate of a company must be submitted with the bid document.
- An original current account in terms of water and electricity/rates and taxes obtainable from any local municipality must be submitted with the bid document
- Certified copies of identities document of Directors and Owners of the company must be submitted with the bid document.
- Failure to comply with these conditions will result in immediate disqualification of the proposals.
- BBBEE Certificate/JV BBBEE Certificate if the company is a Joint Venture.
- Joint Venture Agreement if the company has entered into a Joint Venture and specifying the name of the signatory in the JV.
- Profile of members of the Implementing Agent with their qualification.
- Professional Indemnity to the minimum value of R 2 000 000.00
